The Authority therefore invites eligible bidders (Hotels in Nakuru County) for provision of Full Board Accommodation & Conference facilities for 22 pax from 10th -12th July 2019, Check in on 9th July and check out on 13th July 2019 The venue must have the following minimum requirements:

- 1. Hotels within Nakuru County with a 4* star Rating and adequate capacity (To be confirmed from Tourism Regulatory Authority)
- 2. Adequate single occupancy Accommodation for 22pax Check in 9th July check out 13th July 2019 (Attach Brochure)
- 3. Have a Functional Public Address (PA) System
- 4. Have Functional Projector and projection screen.
- 5. Have a well-ventilated **conference hall** with Capacity to hold targeted No. of participants on **10**th **-12**th **July 2019**.
